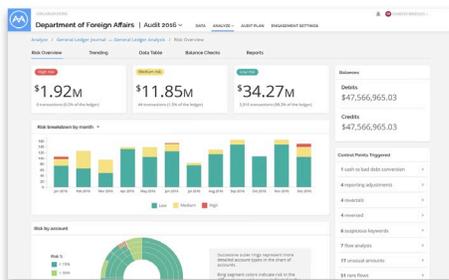

At the same time, public scrutiny of budgeting, financial reporting, and cases of fraud have undermined trust in the public service and elected officials.

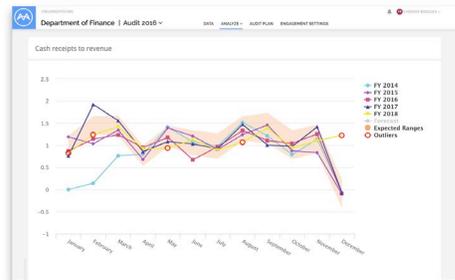

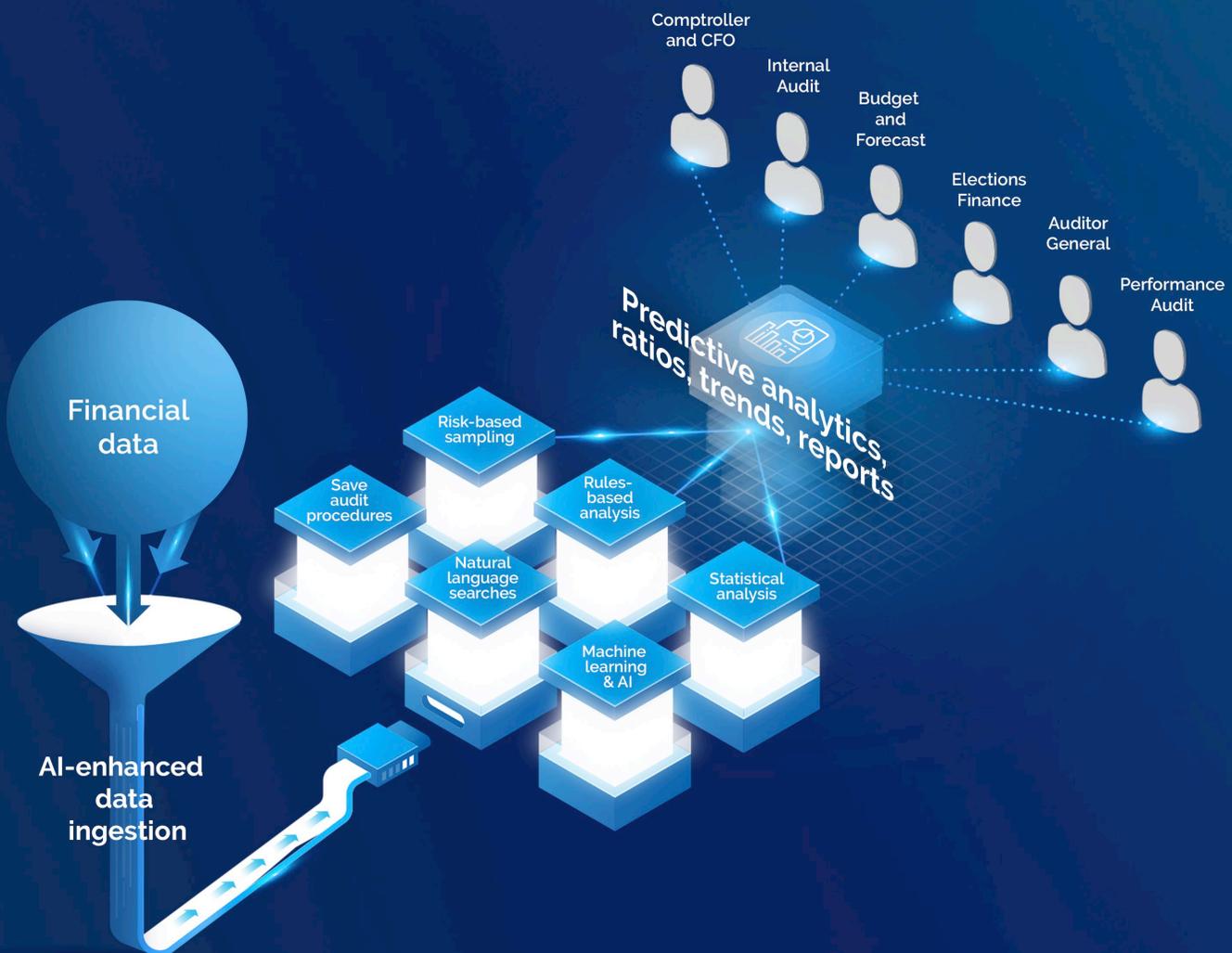

Pre-emptive financial reviews
